Subject : Approval of Sectoral Outlay for the Annual Plan 2008-09 in respect of Chhattisgarh.


Sir,

I am directed to refer to the discussions between Deputy Chairman, Planning Commission and Chief Minister of Chhattisgarh held on 15<sup>th</sup> April, 2008 during which the outlay of Rs. 9600 crore was finalized and the soft copy of the revised outlay received on 28<sup>th</sup> July, 2008.

2. The Scheme of Financing of the Approved Annual Plan 2008-09 is given at Annexure-I.
3. A Statement showing the distribution of the Approved Annual Plan (2008-09) of Rs.9599.00 crore among different heads and sub-heads of development including earmarked outlays is given at Annexure-II. Approval of proposed outlay of Rs.1 crore towards Ecology & Environment has not been accorded without any activity chart on pollution abatement and a complete report on the environment sector. It would be considered at the appropriate time after due consultation between the concerned division in the Planning Commission and the State Government. It is also requested that appropriate action be taken to provide 15 per cent of State share for NRHM Plan activity for 2008-09.
- 4 I am directed to invite your attention to the procedure for sending adjustment proposal and revision of outlays. You are requested to send the adjustment proposals and the proposal for revision of outlays fully supported by Revised Scheme of Financing for the Annual Plan 2008-09, if any, together with appropriate justifications, before 31<sup>st</sup> December, 2008.

5. Statements showing actual expenditure incurred and the corresponding actual Scheme of Financing of the Annual Plan 2008-09 should be sent to Planning Commission before 30<sup>th</sup> September, 2009.
6. The Plan Programme need to be monitored closely with a view to achieve the financial and physical targets.


